"A RESOLUTION APPROVING THE REVISED GENERAL ADMISSION POLICY FOR THE CITY COLLEGE"

WHEREAS, during the August 5, 2022 Regular Meeting of the CCSFP Board of Trustees (BOT), Hon Mayor and Chairperson, Vilma Balle-Caluag expressed her desire for the City College to be socially inclusive for all Fernandinos;

WHEREAS, CCSFP was directed by the Board to revise and reconsider previously denied first year college applicants for the 1st semester of AY 2022-2023;

WHEREAS, the Members of the Board agreed to maximize the capacity of the building and budget versus the number of the total students of the CCSFP;

WHEREAS, the CCSFP's strategic objective is to create an accessible admission policy aligned with the City Government's thrust on social inclusivity under the social impact perspective of its Balanced Scorecard;


WHEREAS, on January 17, 2023, the CCSFP Academic Council resolved to adopt its an "Open Door Policy" which means all students, regardless of their background should have access to quality higher education;

WHEREAS, under the revised admission policy and solely for ranking purposes only the following criteria to be adopted: a) School Ability Test for 50 pts; b) General Weighted Average for 40 pts; 3) Admission Assessment for 10 pts; for a total of 100 pts;

NOW THEREFORE, by the power vested by the CCSFP Charter, the CCSFP-Board of Trustees hereby **APPROVES THE REVISED GENERAL ADMISSION POLICY FOR CITY COLLEGE OF SAN FERNANDO PAMPANGA.**


