AN ORDINANCE AMENDING S.P. ORDINANCE NO. 2008-018, OTHERWISE KNOWN AS THE "CHARTER OF THE CITY COLLEGE OF SAN FERNANDO PAMPANGA" PARTICULARLY ART. II, SEC. 2 (E) AND ART. X, SECTION 4 THEREOF

WHEREAS, the State recognizes the essential role of the youth in nation building and the urgency to provide formal training in their full development;

WHEREAS, in response to this call, the City Government of San Fernando, Pampanga has established the City College of San Fernando, Pampanga by virtue of SP Ordinance No. 2008-018 or the Charter of the City College of San Fernando, Pampanga by providing funds thereof and for other purposes;

WHEREAS, in response to the urgency of providing College and Post Secondary Education as a strong foundation in arming the youth for community and nation building, the Honorable City Mayor through the Committee on Education proposed the establishment of City College of San Fernando that will offer different degree courses in the fields of sciences, arts, education, commerce, engineering, including non - degree programs, that shall also undertake research and extension services and provide leadership in its areas of specialization;

WHEREAS, these objectives were satisfactorily achieved by the City College as manifested by its First Batch of graduates particularly those who have taken the recent Board Examination for teachers, where the first batch of graduate of the City College of San Fernando, Pampanga have recorded the highest percentage in the region and the national levels;

WHEREAS, to ensure sustainability and further upgrade the capability of future students and subsequent graduates, the Sangguniang Panlungsod through the Committee on Education deemed fit to amend the Charter of the City College particularly Art. II, Section 2 (e) and Art. X, Section 4 thereof;

NOW THEREFORE, be it ordained as it is hereby ordained by the 3rd Sangguniang Panlungsod of the City of San Fernando, Pampanga, in session duly assembled adopts as it hereby adopts the amendments of the foregoing Ordinance, to wit:

ARTICLE II
THE BOARD OF TRUSTEES (BOT) which reads:

Section 2. Duties & Functions of the Board of Trustees (BOT) - Subject to existing laws, the Board of Trustees shall perform the following duties and functions to exercise its corporate powers, to wit: xxxx

- e. To approve the courses of study and rules of discipline drafted by the College Council as herein provided.

SHALL NOW READ:

- e. To determine the necessary curricular Offerings based on the demands of the time.
- f. To approve the courses of study and rules of discipline drafted by the College Council as herein provided.

ARTICLE X
MISCELLANEOUS PROVISIONS which reads:

Section 4. Curricular Offerings - The different curricular offerings at the City College of San Fernando are as follows:


